Method of Transportation: Delta Charter Services

I understand that all students going on this trip will conduct themselves in accordance with Modesto City Schools Student Conduct Code. It is further understood that students will go and return from the event in the transportation provided. Students may not provide their own transportation to or from this event. I, the undersigned parent/guardian, assume financial responsibility should the above-mentioned student have to return to Modesto prior to the end of the trip.

I understand that Education Code Section 35330 provides, in part, as follows:
"All persons making the field trip or excursion shall be deemed to have waived all claims against the district or the State of California for injury, accident, illness, or death occurring during or by reason of the field trip or excursion."

PAYMENTS: If needed, the Senior Trip can be paid in 3 installments.

On or before 10/10/18: \$105.00 (1st payment)

On or before 11/15/18: \$105.00 (2nd payment)

On or before 02/05/19: \$105.00 (3rd and **final** payment)

Students are given the opportunity to raise funds through established senior trip fundraisers. Information regarding fundraisers will be announced in the school bulletin, or you may also contact the Student Body Office. Once the trip reaches capacity, a wait list will be started. **To secure a spot, you must submit the 1st payment of \$105.00 by October 10, 2018. The additional 2 payments must be made by their deadline dates listed above. Your final payment is due on February 5, 2019 to guarantee your spot on this year's Senior Trip.**

REFUND POLICY: Refunds of payments made are available up to the final payment due date of 2/5/19. Money from fundraisers will not be refunded to the student, but will revert to the senior trip account. If the student is not able to attend after the final payment date, it may be possible for the student to sell their spot to another eligible senior, but is not guaranteed. **Contractual obligations with Disneyland & Delta Charter Services do not allow for full refunds after the final payment due date. This includes ineligibility, illness or family emergencies that may arise even on the day of the trip. Neither refund or exchange is authorized for passengers who miss the scheduled departure.**

ELIGIBILITY: Only eligible seniors are allowed to go on the senior trip, no guests are allowed. Students with any debts to the school, 2 or more U's (**3rd quarter**), 6th step truancy or 1-2 home suspensions totaling 4 days within a quarter (**3rd or 4th quarter**), substance abuse incident (**3rd or 4th quarter**) are not eligible to go on the Senior Trip. Eligibility will be determined based on 3rd quarter grades, and all requirements are listed in the MCS Student Conduct Code.

NOTE:***3rd Quarter ends after the final payment date. By signing this permission slip, you are agreeing that if your student has paid in full and they become ineligible, you will NOT get a refund, but they might have the opportunity to sell their spot to another eligible Senior.****
