Fundraisers:

You must have both a trip permission slip and a fundraiser permission slip on file in the SBO prior fundraising. **Participating in fundraising DOES NOT reserve your spot on the bus you MUST make a down payment of \$10 and stay up-to-date on payments to reserve your spot.**

Deadlines are firm – no late payments accepted

Payment Schedule:

1st Payment of \$120.00 is due no later than Friday, December 10, 2021

2nd Payment of \$120.00 is due no later than, Friday, February 4, 2022 Final

Payment \$100.00 is due no later than Friday, March 4, 2022

To reserve your space, students must pay the 1st payment and turn in the completed permission forms by December 10, 2021. The additional 2 payments must be made by their deadlines listed above. Your final payment is due on March 4, 2022 to guarantee your spot on this year's Senior Trip.

Eligibility:

Only eligible seniors are allowed to go on the Senior trip. No guests allowed. Students with any debts to the school, 2 or more U's (3rd quarter), 6th step truancy or 1-2 home suspensions totaling 4 days within a quarter (3rd or 4th quarter), substance abuse incident (3rd or 4th quarter) are not eligible to go on Senior Trip. Eligibility will be determined based on 3rd quarter grades, and all requirements are listed in the MCS Student Conduct Code. *Note: 3rd Quarter ends after the final payment date. By signing this permission slip, you are agreeing that if your student has paid in full and they become ineligible, you will NOT get a refund, but they may have an opportunity to sell their spot to another eligible Senior on the Waiting List.*
